VI. NYSPHSAA Report..................Jennifer Keane/Mike Bongino

a. Action Items

- i. 3 Regional Rotation- Start with Fall 2025, equitable rotation, Section VIII and Section XI will be guaranteed to play each other in every sport and then depending on classification there may be an additional game before heading to State Semi Finals depending on year and rotation schedule. At Large Bid- Section IV can have bid to fill brackets because they don't have a "neighbor" to play, which could lead to both teams advancing to State Semi Finals.
 - Section VIII will bring up at the State Meeting the condition to
 predetermine that at large will follow a specific track and the winning
 team will follow a predetermined track. Concern regarding who will
 officiate these regional games, right now Section VIII & XI are the only
 who split officials during that game. Conversations regarding neutral
 officials and how they will be selected. With at large bid there is a
 potential for two teams in the same section playing in the State Finals.

- ii. Move the 8 man football finals to move to another weekend other than 11 man football. APPROVED
- iii. No longer recognize Competitive Cheer in the Fall, only in the Winter (this is no change for section VIII). Can still perform Game Day at Nationals. APPROVED
- iv. Cheer Choreography- cannot do choreography till start date in August.APPROVED
- v. DEI Committee- update language in NYSPHSAA handbooks. APPROVED
- vi. Championship Philosophy- consistency approach for awards to represent all sports equally. Rational- streamlining so individual sports award up to 10 places, if the sport has more than 75 individuals can award up to 20 places. Team sports award up to 4 teams. 1st/2nd plaques and medals. 3rd/4th plaques only. Eliminate section team awards/medals/t-shirts. Representatives will vote based on conversation at the meeting.
- vii. Eliminate regional runner up plaques. APPROVED
- viii. Sport season committee- consider approval for Fall sports to start two weeks before labor day and football on week 7. Section can be more restrictive but cannot start before the State start date. APPROVED
- ix. Sport season committee- consider approval for spring sports to start in the second week of March. Section can be more restrictive but cannot start before the State start date. APPROVED
- x. Gymnastics States will be hosted at CSH HS. APPROVED
- xi. Eliminate all noise makers in the girls lacrosse contests. Section VIII will bring up all sports. APPROVED
- xii. Scrimmages to be permitted after 6th practice for Baseball. APPROVED
- xiii. Venues for State competitions. APPROVED
