XVI. <u>Unfinished Business</u>

- a. Non-League Games
 - i. Overview: For all sports and all conferences-league season games is the focal point for how you seed for the playoffs and non-league games have no impact on playoff schedule. Need to discuss if non-leagues could be considered for tie breaker purposes.
 - ii. Discussion:
 - 1. Due to BEDs you could be in a much easier conference or difficult conference if not an ability based.
 - 2. Power conferences typically get bids to playoffs regardless.
 - 3. NL games are used for various reasons. For challenge or for learning experience.
 - 4. Open seeding will still be available to all sports regardless of power/ability league or enrollment.
 - iii. Motion: Non league games will not be a factor in playoff seeding for all sports immediately.
 - 1. Motion to approve: 1st (SS), 2nd (JK).
 - a. Discussion: larger discussion than 20 minutes, need input of coaches, coordinators (boys basketball) looking for guidance regarding non league impact so they can complete their handbooks and structure. Boys soccer would be immediately impacted for the fall season. Within this motion, NL cannot be used as the tie breaker process. Using NL to qualify for playoffs is different then using NL for seeding.

It is in the rules that a section can select the pathway however Section VIII will send the winner of the County Games to the LIC's.
