  - f. Volleyball- home/away- If we go home/away there would be approx. 278 JV games (boys & girls) that would not be covered. Officials association also stated they are not recruiting as they do not add more officials because the current association would get less games. Explore if ethics should look into this regarding their contract. How is it comparable to soccer, baseball, softball, etc? Flag Football

- a. Conferences based on last year's results. Farmingdale and Wantagh added to conference 3 based on being new teams. Originally based on last year's results- Conference 1 is a power league, conference 2 teams developing and experience and conference 3- developing/new programs. Based on feedback from ADs/Coaches went back to committee and developed a relief schedule to include all C schools into conference 3 along with all teams that need relief. Teams selected for conference 2 were based on last year results, win/loss, competitive schedule from previous year.

- a. Motion: To amend the flag football alignment that was approved last meeting from ability based alignment to enrollment with relief alignment.

- b. Onside rule for regular season and post season for next year. During scrimmages, NL and cross overs (which do not count for playoffs) try it so we have feedback to contribute to the discussion for next year.

- d. Flag football uses the lacrosse lines breaks with cones last season. May still use cones but can also use turf safe paint (of a different color) from lacrosse lines.

#### JV Girl's Lacrosse

- a. Alignment approved within committee, going to coaches next due to request for relief for JV alignment. State meeting on Monday will discuss shot clock at JV information as of now it will likely be optional. If it passes, all JV teams will need to agree prior to the game to use or not use the shot clock. How will back to back be impacted since Varsity and JV will not be playing some teams in cases? There will still be some school that will have back to backs. Coaches expressed not liking back to back so we can look into pilot similar to volleyball.
